

## **BOOTH FLOOR PLAN FILING REQUIREMENTS**

Deadline: December 11, 2019

Each exhibiting company must submit a booth drawing/rendering of the planned booth construction, showing height, depth and width. The height and placement of furniture and all displayed products or equipment must be included. This drawing/rendering must be submitted by December 11, 2019, regardless of booth size.

Your display products must fit within the confines of your display area and must be arranged in such a manner to not obstruct neighboring exhibits. Anything not complying with ATD's Exhibit Design Regulations will be removed - NO EXCEPTIONS!

In order for your booth drawing/rendering to be accurately and quickly processed upon receipt, **YOU MUST ATTACH YOUR FLOOR PLAN TO THE FLOOR PLAN REPORTING FORM**.

ATD Show Management will review booth drawings/renderings for compliance with ATD's Exhibit Design Regulations. We do not send approvals. If your booth may be in violation, we will contact you.
